3. Assume all of the foregoing risks and accept personal responsibility for any damages that may result from injury, permanent disability or death.
4. Enter martial arts training entirely of my own free will and understand the importance of following the rules of training.
5. I certify that I am in good physical condition, and have no disease, injury or other condition that would impair my performance or physical and mental well-being during intense training practice and/or competition.
6. Grant permission in case of injury to have a doctor, nurse, athletic training or other emergency medical personnel provide me with medical assistance or treatment for such injury.
7. Release, waive, discharge and covenant not to sue, Phoenix Wushu Academy, its affiliated organizations and governing bodies, their officers, instructors and personnel, other members of the organizations, participants, supervisors, coaches, sponsoring organizations or their agents, and if applicable, owners and leasers of the premises from any and all liability to the undersigned, his or her heirs and next of kin for any and all claims, demands, losses and damages which may be sustained and suffered on account of injury, including death or damage to property, caused or alleged to be caused in whole or in part by the negligence of the releases or otherwise.

The Martial Code of Ethics

Respect, Humility, Trustworthy, Loyalty, Virtue and Honor

Students and parents of the Phoenix Wushu Academy must abide by the following rules and regulations of the school and the martial code of “Wu De” as listed below:

- Students and parents must exhibit honor, respect, humility, loyalty, kindness, trust and virtuous character.
- Students that are currently taking classes at the Phoenix Wushu Academy are prohibited from learning from another master, coach, or instructor teaching the same artform.
- Students and parents must respect all personnel in Phoenix Wushu Academy, as well as other students and parents.
- Students and parents are to under no circumstances cause strife or chaos in the school.
- Slandering or defamation of any kind will not be tolerated.
- Students and parents are expected to settle disagreements in a civil manner.
- Students and parents are prohibited from soliciting students from the Phoenix Wushu Academy under any circumstances and will be subject to legal action if such conditions should arise.

Violation of the school regulation and martial code of “Wu De” by any student or parent will be subject to expulsion without refund of tuition required.
