- 6 Grant permission in case of injury to have a doctor, nurse, athletic training or other emergency medical personnel provide me/my child with medical assistance or treatment for such injury. I further authorize the release to health professionals any medical and personal information Phoenix Wushu Academy may have regarding the student in the subsequent medical treatment of the student. I certify that my child is covered by a medical plan or health insurance that covers
